These vehicles may only be supplied to the market (delivered to a person to tow behind a road motor vehicle) if they comply with the requirements of Vehicle Standards Bulletin 1.

Registration requirements

Import approval does not exempt these vehicles from State or Territory registration requirements. You should determine these requirements from the motor vehicle registration authority in the State or Territory where you intend to register the vehicle.

Offences

Serious offences apply if you import a vehicle or supply a vehicle to the market other than in accordance with the Act and this approval.
